

**THE 2018 BOSCH #SAVORTHEDETAILS CONTEST OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, PLAY OR CLAIM A PRIZE.**

**A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.**

**OPEN TO ALL LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA.**

**MUST BE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY TO BE ELIGIBLE.**

**VOID IN PUERTO RICO AND ELSEWHERE WHERE PROHIBITED BY LAW.**

The 2018 Bosch #SavorTheDetails Contest (the “Contest”) is sponsored by BSH Home Appliances Corporation, 1901 Main Street, Suite 600, Irvine CA 92614 (“Sponsor”).

- 1. BRIEF OVERVIEW OF 2018 Bosch #SavorTheDetails Contest:** The Contest commences on May 29, 2018 on/before 9:00:00 AM Pacific Time (“PDT”) and ends on August 5, 2018 at 7:59:59 PM PDT (the “Contest Period”). Contest entry commences on May 29, 2018 on/before 9:00:00 AM Pacific Time (“PDT”) and ends on July 8, 2018 at 7:59:59 PM PDT (the “Contest Entry Period”). The Contest Voting commences on July 16, 2018 on/before 9:00:00 AM Pacific Time (“PDT”) and ends on August 5, 2018 at 7:59:59 PM PDT (the “Contest Voting Period”). The Contest consists of Ten (10) Grand Prize Winners and Twenty Five (25) Secondary prize winners as determined by public voting. The Contest has the Start Date and End Dates as set forth in the table below.

The computer of the Sponsor shall be deemed to be the official Contest Period clock.

**2. ELIGIBILITY:** This Contest is open only to legal United States residents in the 50 United States and District of Columbia, 18 years of age or older, established at the time of entry. Employees of Sponsor, and its respective parent company, affiliates, subsidiaries, advertising, promotion and production agencies, and their immediate family members (i.e., spouse, parent, child, sibling, and the “steps” of each) and persons living in the same household of each (collectively, “Sponsor and Others”) are not eligible to enter. All federal, state and local laws and regulations apply. Void in Puerto Rico, the United States Territories and Possessions, and elsewhere where prohibited or restricted by law. Participation constitutes Entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to this Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein. If it is discovered that an Entrant has entered or attempted to enter more than one time per Prize Period using e-mail addresses, telephone numbers or multiple identities, all of the Entrant’s entries will be declared null and void and any prize an Entrant might have been entitled to will not be awarded. For the purposes of this Contest, a “day” shall run from 12:00:00 AM PST to 7:59:59 PM PST, except for May 29, 2018 and July 16, 2018 when the “day” will start on/before 9:00:00 AM PST.

- 3. HOW TO ENTER THE CONTEST:** To enter, go to the Bosch Savor the Details Contest website [BoschSavorTheDetails.com](http://BoschSavorTheDetails.com). Click on the link associated with the Contest during the Contest Entry Period. In order to enter, you will be required to check a box indicating you are 18 years of age or over and your acceptance of these Official Rules.

Bosch and a third party, Finn Partners, will review each Entrants submission within 48 hours of being shared. If the photo or video #SavortheDetails Entry is deemed appropriate per the Sponsor’s ethics policy, the submission will be published on the Contest gallery page. Entries must not, in the sole and unfettered discretion of Sponsor, contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content.

Entry text may also be revised to correct typos/grammar, or edited for length.

An Entrant may enter the Contest only one (1) time during the Contest Entry Period regardless of how many e-mail addresses an Entrant owns, possess, and/or uses. Contest entries will be monitored via tracking cookies. By entering this Contest, you are providing your information to the Sponsor and third party, Finn Partners.

During the Contest Voting period, users can vote for their favorite Entry. Each user can vote once daily. Voting is not considered an Entry and voters are not eligible for the Grand Prize or Secondary Prizes.

**4. WINNER DETERMINATION:** Once the Contest Voting Period ends, the ten (10) eligible Entries with the most votes will be deemed the Grand Prize Winners. The twenty five (25) eligible entries with the next most votes will be deemed Secondary Prize Winners. In event of a tie, Winner will be determined based on the judges' discretion.

#### **5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV") AND ODDS OF WINNING:**

**A. Grand Prizes:** Ten (10) Grand Prizes consisting of a trip for two (2) to Irvine for a dinner prepared by Chef Curtis Stone. The Sponsor will provide for airfare, accommodations, transportation from September 20, 2018 to September 22, 2018. The dinner will take place in Irvine at the Bosch Experience and Design Center in Irvine, CA on September 21, 2018.

**B. Secondary Prizes:** Twenty-five (25) Secondary Prizes consisting of a Curtis Stone cookbook. The gift bundle will be shipped to the secondary prize winners within one (1) month of the contest end date.

**C. Odds of Winning:** The odds of winning depend upon the total number of eligible entries received on the Bosch Savor the Details Contest website during the Contest Entry Period.

**D. Approximate Retail Value of Prizes**

Approximate Total Retail Value of all prizes is USD \$75,875.00.

Approximate Total Retail Value of each Grand Prize is USD \$7,500.00.

Approximate Total Retail Value of each Secondary Prize is USD \$35.00.

#### **6. HOW TO CLAIM A PRIZE, AFFIDAVITS AND RELEASES:**

**A. Prize Notification:** The ten (10) potential Grand Prize Winners will be notified by e-mail and/or telephone. If any of the potential winners cannot be contacted by e-mail or telephone within ten (10) days of attempted first notification he/she will forfeit his/her prize. The releases hereunder are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of laws requiring the intent to release future unknown claims.

Sponsor uses reasonable commercial efforts to comply with Federal CAN-SPAM law and entrants may subsequently opt-out of receiving further emails by following opt-out instructions contained in Sponsor's privacy policy. Entries will not be acknowledged or returned.

**10. PUBLICITY RIGHTS:** By entering, entrants agree and consent to allow Sponsor, and each of its successors, assigns, transferees, licensees, and sublicensees to use, replicate, alter, adapt, modify, publish, broadcast, translate, produce derivative works from, distribute, present, play, and exercise all copyright and other intellectual property rights with respect to the entrant's full name, city and state of residence, Entry and any reviews, photographs or other likenesses, pictures, portraits, voice, testimonials, and biographical information (in whole or in part), worldwide, royalty-free and in perpetuity for any and all purposes, including, but not limited to, advertising, trade, syndication, and/or promotion on behalf of Sponsor, in any and all forms of media, now known or hereafter devised, including, but not limited to, print, TV, radio, cable, electronic, digital, social media and any third party websites (including pursuant to the terms of use and policies of those websites) or World Wide Web, without further limitation, restriction, compensation, notice, review, or approval to the extent permitted by law, which rights entrants acknowledges and agrees Sponsor can transfer, assign, license, and/or sublicense said rights.
